## **Honors and Awards**

2025, 2024, 2023, 2022 “Highly Ranked Scholar - Lifetime” by ScholarGPS® in the Specialty of Alcohol Abuse publications. Each year since 2022 ScholarGPS® has ranked individual scholars and institutions worldwide based on their publications in various fields of study and specializations. The honor of Highly Ranked Scholar for scholarship on alcohol abuse was conferred to H. Wesley Perkins each year between 2022 and 2025 for lifetime scholarship by ScholarGPS with the citation: *“in recognition of exceptional productivity, noteworthy impact and quality of scholarly work in the top 0.05% of scholars in the Specialty worldwide.”* In 2025 the selection included only 7 honorees and was made based on publicly viewable rankings from a data base of more than 16,000 peer scholars globally who had authored multiple articles overtime in the specialty of Alcohol Abuse. The unbiased rankings are created on the basis of a composite standardized metric score that takes into account 1) the number of publications a scholar has in the specialty (with author contribution being reduced by the number of other authors credited with making a contribution in each article), 2) the impact of a publication based on its number of citations (excluding self-citations), and 3) the quality of scholarship as assessed by the h-index.

2016 Community Collaboration Award given by Success for Geneva’s Children, a Geneva, New York organization dedicated to mobilizing the community to improve the health and well-being of local children and their families. The annual award was given to Perkins in recognition of his significant work over the last ten years to enhance the community understanding of local youth by providing professional guidance in preparing multiple data books on the health and well-being of the city’s children. The data books comprising facts and figures drawn from local, regional and national sources and data bases compare social and demographic information regarding Geneva and its children with that of the wider county and state and are recognized to have helped procure almost 4 million dollars in grant funding for local needs.

2005 Project Director of Alcohol Education Project that received a U.S. Department of Education "Model Programs in Higher Education" award for the development of a program with demonstrated effectiveness in prevention of alcohol abuse among college student-athletes at Hobart and William Smith Colleges. This is the second time the award was given to the Project under Perkins’ direction.
